		<b>If there is a Peruvian Diplomatic or Consular Mission in your country:</b>	Travelers must file a visa application in the Peruvian Diplomatic or Consular Mission with the following accompanying documents: <ul style="list-style-type: none"> <li>• <b>Form DGC-5</b> de visa application</li> <li>• A copy of the identification page from a Valid Passport, with minimum validity of six months</li> <li>• One color photograph, facing forward, with a white background, including (uncovered) head shoulders. Size of photo must be 2 inches x 2 inches or 51 mm x 51 mm.</li> <li>• A copy of the Annual Meetings Registration Confirmation Letter</li> </ul>	<b>Delegates, Staff, Observers, Guests, CSOs, Speakers, general Participants and their Family Members will be on OFFICIAL VISA at No Fee, upon presentation of Annual Meetings Registration Confirmation Letter.</b>
	Those traveling on national passports from countries not on the aforementioned list, <b>REQUIRE</b> a visa to enter Peru.	<b>If there is no Peruvian Diplomatic or Consular Mission in your country:</b>	Electronic official visas may be requested and issued online via the following link: <a href="http://VisasJuntasBM-FMI.rree.gob.pe">http://VisasJuntasBM-FMI.rree.gob.pe</a>  Participants must upload the following documents: <ul style="list-style-type: none"> <li>• A copy of the identification page from a Valid Passport, with minimum validity of six months</li> <li>• <b>Form DGC-5</b> de visa application</li> <li>• One color photograph, facing forward, with a white background, including (uncovered) head shoulders. File size must be less than 500 Kb.</li> <li>• A copy of the Annual Meetings Registration Confirmation Letter</li> <li>• After verification all requirements have been fulfilled, The Ministry of Foreign Affairs will issue an "Official e-Visa", to allow applicants to board their flights.</li> </ul>	<b>Delegates, Staff, Observers, Guests, CSOs, Speakers, general Participants and their Family Members will be on OFFICIAL E-VISA at No Fee, upon presentation of Annual Meetings Registration Confirmation Letter.</b>
